

## **SUMMARY ANNUAL REPORT**

### **For The University of Chicago Health Care Plan**

This is a summary of the annual report of the The University of Chicago Health Care Plan, EIN 36-2177139, Plan No. 510, for period January 01, 2019 through December 31, 2019. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Insurance Information**

The plan has contracts with Bluecross Blueshield HMO Illinois, Metropolitan Life Insurance Company, Principal Life Insurance Company, Bluecross Blueshield of Illinois, Visison Service Plan and Massachusetts Mutual Life Insurance Company to pay health, dental, vision, life insurance, HMO, PPO and indemnity claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2019 were \$78,430,088.

#### **Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$80,272,729 as of December 31, 2019, compared to \$64,153,995 as of January 01, 2019. During the plan year the plan experienced an increase in its net assets of \$16,118,734. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$156,425,978, including employer contributions of \$102,553,654, employee contributions of \$38,242,419, other contributions of \$389,991, and earnings from investments of \$15,239,914.

Plan expenses were \$140,307,244. These expenses included \$209,316 in administrative expenses, and \$140,097,928 in benefits paid to participants and beneficiaries.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (The University Of Chicago, 6054 S Drexel Ave., Chicago, IL 60637) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
